With my fading respect, Can someone tell me why this matter has not been addressed. Last note was that a crossing guard is planned. We are at nearly two months since expressing this concern and NOTHING (at least from what I know). Sadly for the protection of these young kids the school administration each and every morning rain or shine has someone out there taking on great risk to help direct traffic and guide families across the

Now - I am frustrated and I am going to explain it in detail because if any child is injured due to in part the lack of the districts immediate attention to this severely dangerous intersection and lack of proper action or follow up to my initial letter of concern I will support any family member by supplying supporting documentation such as my letters along with video evidence to support any legal action that may be taken as a result of an injury to anyone of which should have been prevented should the District simply taken steps – immediate steps assuring the safety of the children attending Boone, their families and/or neighbors. Lets get a crossing guard working, we need to bring attention by placing some blinking lights or something - A stop sign is a very common sense move on 22nd at Prout.

The flow of traffic down Prout Street to 22nd street or 22nd down Prout to Pennsylvania is far greater than what this residential street can hold. Since parking along both sides of Prout Street is permitted it dramatically reduces four lanes into wo barrley. You can barrly fit both lanes of parked traffic and two lanes of moving traffic of any direction, To make things worse the district has permitted parking on both sides of 22nd street beginning at Prout Street to the Fairlawn Ave. This means folks picking up or dropping off drive down 22nd from Minnesota drop the student off and then proceeds to head down intro the one way traffic to either navigate around head on oncoming traffic or they will attempt to make a u-turn using the intersections which blocks traffic from all directions until they turn to go back up 22nd street. On one more traffic issue with this intersection - if you come from PA Ave towards 22nd who actually stop and turn left on 22nd you! I quickly find out that you need to pull out past the stop sign to view the line of cars lined up and parked along both sides of 22nd then inch your way out even further to see past the line of cars to make sure no one is speeding down 22nd at this point your half way out into the intersection exposed to anyone speeding down 22nd from Fairlawn.

I'm surprised I thought you would have had this matter addressed and followed up to make sure the issue was resolved in a timely manner - maybe had you actually requested police, not only would it provide a great opportunity for our MPD to do some community policing with the kids and families (granted some may not like that police are there - I understand however the safety of everyone is priority) it will alert people to not make the Uturns, blow their horn etc. I informed you of my concerns I was not asking you what you were going to do, I would have hoped you would have relayed my concerns and possible solutions frankly I don't really care what you ask for looks like your influence doesn't affect too much anyway since it remains unresolved and I've gotten no update from you or anyone else. If I may, I suggest you head out one morning or afternoon spend some time with the school administration to see the situation for yourself of course if you're unable I have plenty of video footage you can review however I'd think standing out there while our neighbors walk the kids to school that it would provide a great opportunity to network with your constituents. I know I still have not seen you at my door in the 5 years I've lived here maybe one day you'll surprise me.

Maybe you have offered some follow up if you have Thank you. If you haven't please stay on top of it. Frankly my opinion is this entrance should not be on a residential street without the necessary room to provide for two lanes of traffic coming and going down the street. With a row of cars on both sides I doubt you can fit two cars side by side the parked cars without hitting one and goodness I'd hate to have my car side swiped because there wasn't enough room. Maybe you can install some blinking lights or something that brings light to it being a school crossing or something,
